AMENDMENT No.# 1

THIS AGREEMENT is made and entered into by and between the State of New Mexico, Public School Facilities Authority, hereinafter referred to as the "PSFA" and **Certerra Southwest, LLC (formally Western Technologies Inc.)**, hereinafter referred to as the "Consultant."

IT IS MUTUALLY AGREED BETWEEN THE PARTIES THAT THE FOLLOWING PROVISIONS OF THE ABOVE-REFERENCED CONTRACT ARE AMENDED AS FOLLOWS:

1. **Name Change**

Contractor name changing to Certerra Southwest, LLC, formally Western Technologies Inc. All other terms and conditions of the contract to remain the same.

2. **Term.**

This Agreement shall begin on the date approved by the PSFA and shall end on January 8, 2027 unless terminated pursuant to this Agreement's Termination Clause or Appropriations Clause. The PSFA reserves the right to renew the Agreement through a written amendment signed by all required signatories, but in any case the Agreement shall not exceed the total number of years allowed pursuant to NMSA 1978, § 13-1-150.

**All other articles of this contract remain the same.**
